Washington January 6th, 2021 - The U. S. Department of Agriculture's Commodity Credit Corporation today announced the 2021 graded loan rates by micron class, as well as the repayment and loan deficiency payment rates for wool and mohair. The effective repayment rate is the lower of either the 30-day average or weekly rate. Loan rates for ungraded wool and mohair are unchanged.
