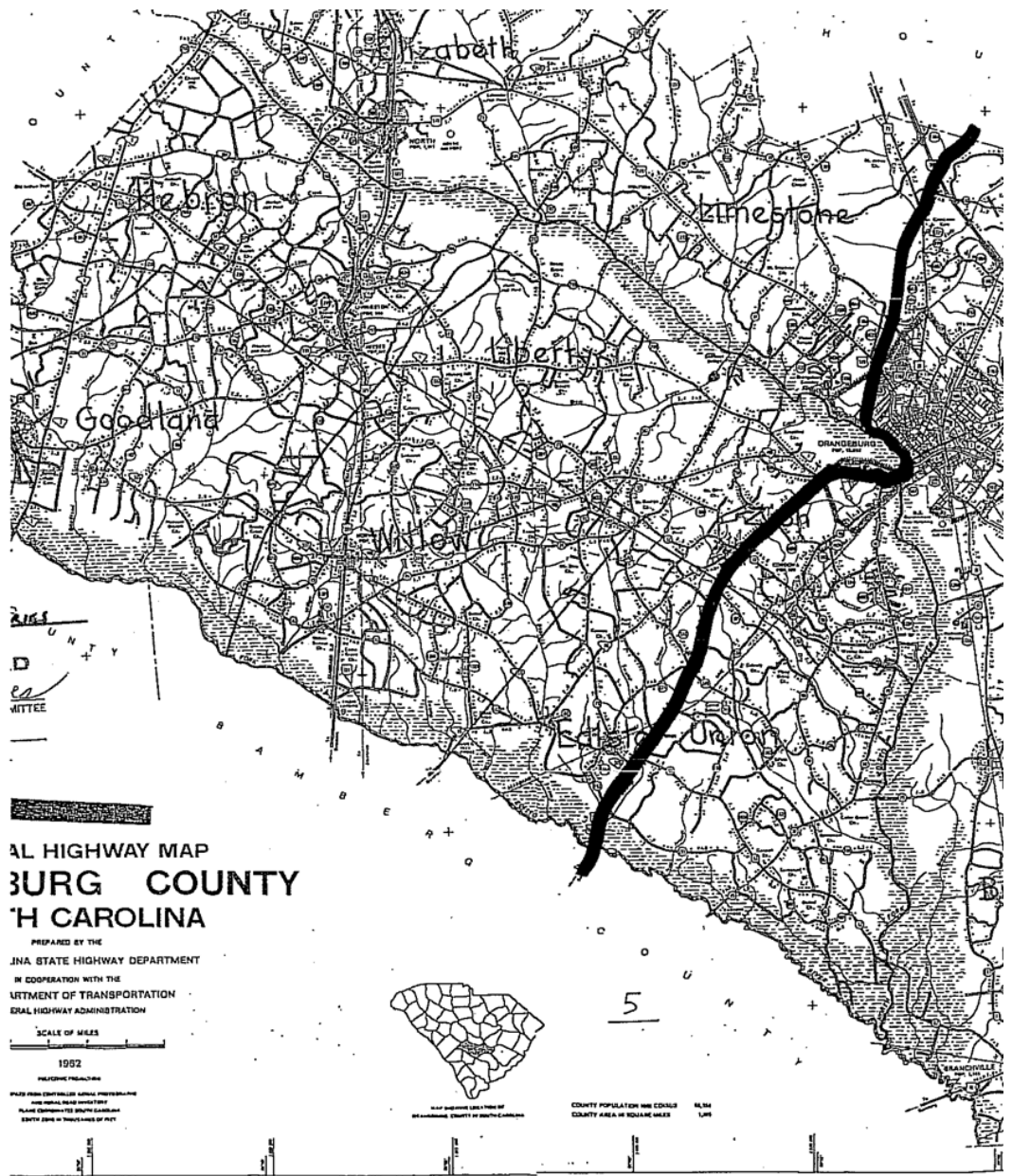

### New Proposed Boundaries for Orangeburg County LAA 1 and LAA 2

The Orangeburg County FSA Committee is proposing to amend the boundaries for Local Administrative Areas (LAA) 1 and 2. The new proposed boundaries are as follows: bordered on the south by the Edisto River (South Fork), on the west by Aiken and Lexington Counties, on the north by Calhoun County, and on the east by Caw Caw Swamp, the Edisto River (North Fork), and Highways 301 and 601.
